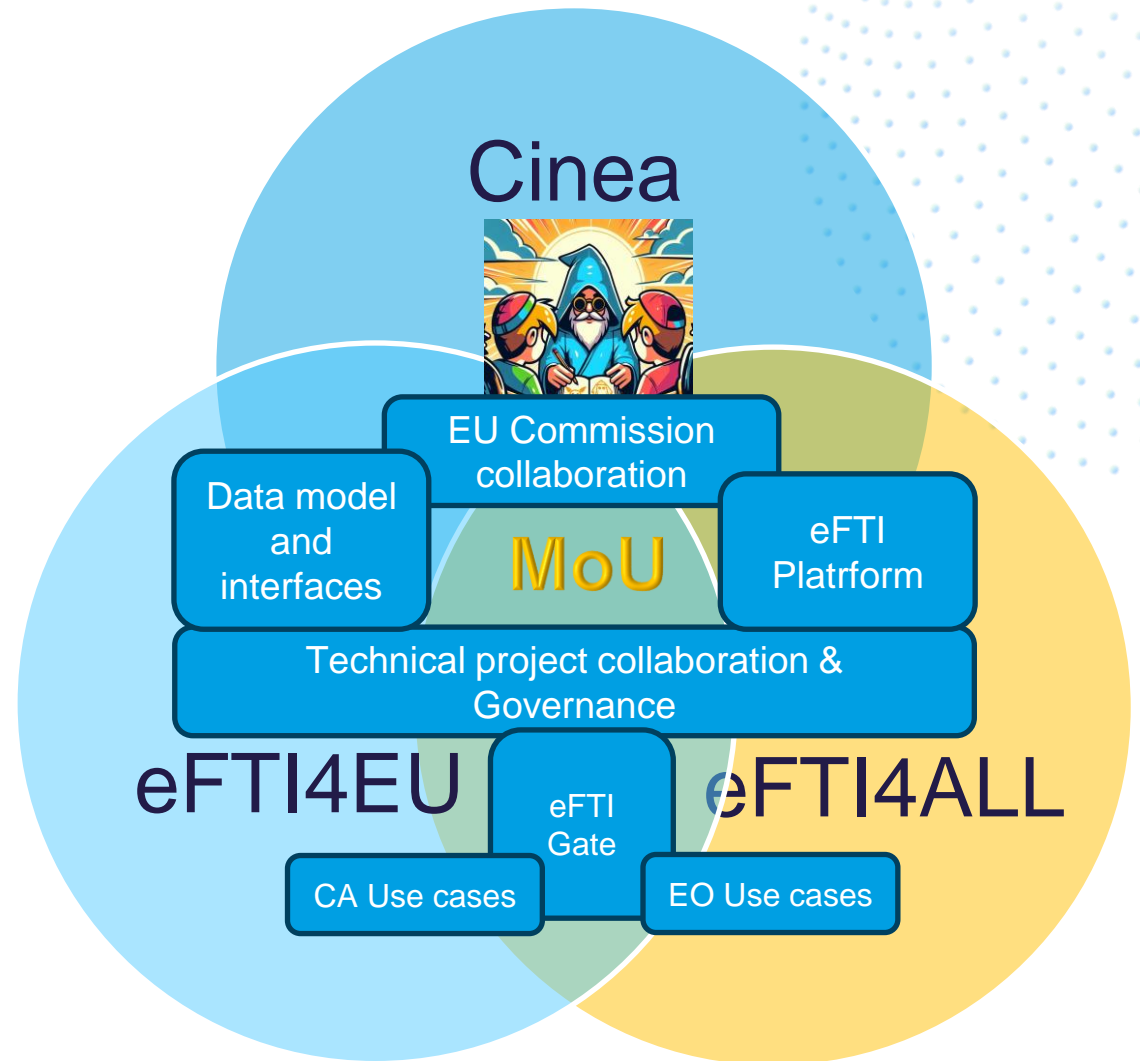

eFTI4EU and eFTI4ALL – coordination

- eFTI4ALL has a lot of synergy with eFTI4EU project, but also independent implementation and clear new value with new Member States and new use cases with increased Economic Operator implementation focus reaching until 2028.
- The two projects have clearly different focus of work – eFTI4EU is authority and eFTI Gate/Data model focused while eFTI4ALL is more economic operator and eFTI platform/interoperability focused
- eFTI4ALL starts with the early deliverables of eFTI4EU: national roadmap, eFTI reference implementation, common pilots. eFTI4ALL project will utilize reference implementation release 0.5 as a foundation for further work.
- eFTI4EU - eFTI4ALL MoU will define the three party collaboration and is to be signed in eFTI4ALL kick-off on November 25th to 26th in Brussels .
